### **VILLAGE INFORMATION**

**Use of All-Terrain Vehicles:** Use of All-Terrain Vehicles is covered under [Traffic Bylaw No 18/2013.](#)

Article 4 (k) (iii) states “Every person who intends to operate an all-terrain vehicle within the limits of the Resort Village of Glen Harbour shall first register his/her all-terrain vehicle with the Resort Village Administrator along with a one-time \$10.00 registration fee. Article 4(k)(iv) Upon receipt of the one time \$10.00 registration fee, the Administrator of the Resort Village of Glen Harbour has provided the registrant with a registration identification plate that shall be clearly displayed on the rear of the all-terrain vehicle at all times.”

Article 6 (f) states “All-Terrain Vehicle Contravention: The penalty for contravention of section 4(k) shall be liable to the penalty imposed by Section 32 of *The All-Terrain Vehicles Act.*”

Article 4(e) “The operator of a vehicle shall not execute “power turns” on any highway (road) in the Municipality.”

Article 4(g) “No person shall operate a vehicle in the municipality at a speed greater than thirty (30) kilometres per hour.”

Reminder: All operators of an All-Terrain Vehicle (ATV) must be 16 years of age and hold a valid drivers license.

**Dust Control Application:** The village Dust Control application is scheduled for June 6<sup>th</sup>, weather permitting.

**Fire Call out:** Fire emergency services come from Strasbourg. The call out fee has increased to \$7,000 for a 3 hour call out with a call for another fire department billed at the cost of the equipment contractor providing the service. “Controlled Burns” Fire Call out is charged to the property owner It would be wise to increase your Insurance to cover this increased amount. If you need fire protection services, call 911 and a fire department will respond. In the event that you are conducting a controlled burn, be sure to notify the

Controlled Burn officials in order to avoid potential fire callout fees if someone else calls in a fire report on your behalf. Controlled burn Notice: 1-866-404-4911

**Public Washrooms:** Hours for the public washrooms for the summer are 9:00 am to 9:00 pm.

**Camper/RV Temporary Use Policy 2023:** With the Zoning Bylaw Review still in progress, Council is currently updating the Camper Trailer/RV Temporary Use Policy and will advise residents once complete.

**“Eppie Pens”:** who has one? If we knew who carried an Eppie Pen the Village could call on for you for Emergency use – Wasp and bee bites – Kachluba has an adult and child’s, Always call 911 for bee and wasp stings it appears the person is having an allergic reaction.

**Dutch Elm Disease:** In Saskatchewan it is against Provincial Regulations to trim or cut Elm trees from April 1 to August 31<sup>st</sup>. If your Elm trees need attention because of lightning strike, snow or wind damage, you can remove the branches or the whole tree, but you must dispose of the wood in a designated location.

Arthur Olaf Berg (Art Berg) passed away Thursday, April 27<sup>th</sup>, 2023. Art was a permanent resident of Glen Harbour before moving into Regina. He also served as a Resort Village Councilman for one term. Family members retain the home as a summer residence.

**Historical Facts:** It is hard to imagine Glen Harbour without trees, but that is how the settlers found it. It remained prairie and farm land for many years except for a few Lilac bushes planted around the farm home. It is fortunate for the current residents that a few individuals had a far reaching view to beautifying the resort. Approximately 45 years ago, before our incorporation, Fred Shtuka and friends, Steve Ebbes, Ray Kachluba, and Harvey McEwen began bringing trees from their trips north. They also started small Poplar trees, and Caragana hedges. Fred bought a tree planter and if requested would move a tree to someone’s lot. The results of their labors are with us to this day. During Cindy Taylor’s service on council under Mayors Dave Radu and Cliff Dunn, she contacted the PFRA Nursery in Indian Head to procure tree seedlings free of charge. With the help of some volunteers they were planted along the parking area at the beach and the road adjacent to the Harvey McEwen Park. One tree still stands, the rest are gone due to dry conditions, floods, and beavers. Stan Dahl and Randy Kachluba have been the benefactors of the trees around the circumference of the Harvey McEwen park. And Stan Dahl has planted a row of Lilacs on the north side of the horseshoe pit. We hope the generations to come will enjoy the efforts of these folks for many years .
