BYLAW NO. 01/2006

A BYLAW TO ESTABLISH A RECREATION BOARD AS PER SECTION 8 OF THE MUNICIPALITIES ACT.

The Council of the Resort Village of Glen Harbour in the Province of Saskatchewan enacts as follows:

1. The establishment of a Recreation Board for the control, supervision, and management of the recreation facilities within the Resort Village of Glen Harbour, and Board shall mean the Recreation Board appointed pursuant to this Bylaw.

2. A Sports and Recreation Board (herein referred to as "Board") authorized by the Resort Village of Glen Harbour (herein referred to as "Council") to provide social activities and events within the Village as well maintenance duties related to recreational facilities. The Board will be comprised of volunteers from the community and may include a member of Council.

3. The Council provides authority for the Board to operate. Events, activities, developments etc. must be agreed upon with Council.

4. The financial authority will remain with Council.

5. The mandate of the Board is to provide for the community of Glen Harbour: social events, activities, developments and some maintenance related to the beach area and recreational facilities such as, but not limited to, buildings, gazebo, playground equipment, horseshoe pits, ball diamond, swimming buoys and diving platform. All such events, activities, developments and maintenance must be mutually agreed upon by both the Council and the Board.

- 6. The Board is responsible for the following:
 - 1. Invite community volunteers to participate in planned events, activities and development projects.
 - 2. Ensure that the Board is comprised of at least six members
 - 3. Hold and conduct at least two meetings annually
 - 4. A majority of the Board is necessary to form a quorum and no business shall be transacted unless there is a quorum.
 - 5. Pay all costs and expenses associated with the activities of the Board with the exception of insurance costs.
 - 6. Maintain all equipment, structures, etc. used by the Board unless otherwise agreed to by the Council.
 - 7. Obtain authority from Council for use of public reserve for special events.
 - 8. Maintain accurate records of expenditures/revenue and submit to the Clerk for official processing. The Council will have signing authority for payment of all expenses.
 - 9. Provide the Council with a proposal including the allocation of budget funds related to the annual activities, events and developments no later than April 30 of each year.

- 10. Provide the Council with regular reports at the scheduled Village Council meetings.
- 11. Council and the Board are encouraged to participate in all grants available.
- 12. The Resort Village of Glen Harbour will retain ownership of current and new equipment, all current and new developments.
