

RESORT VILLAGE OF GLEN HARBOUR

Bylaw 01/2000

A BYLAW TO REGULATE THE OPERATION, PARKING OF VEHICLES AND THE USE OF THE HIGHWAYS.

The council of the Resort Village of Glen Harbour in the Province of Saskatchewan enacts as follows:

1. Interpretation

- (a) "clerk" means the clerk/administrator of the municipality.
- (b) "highway" means a road, driveway, parkway or place designated and intended for or used by the general public for the passage of vehicles, but does not include any area, whether private or publicly owned, that is primarily intended to be used for the parking of vehicles and the necessary passageways on that area and does not include a provincial highway within the municipality as designated by The Highways and Transportation Act, 1979.
- (c) "municipality" means the Resort Village of Glen Harbour.
- (d) "parking" has the meaning ascribed thereto by The Highway Traffic Act.
- (e) "special constable" means Royal Canadian Mounted Police or a person appointed to enforce municipal bylaws.
- (f) "vehicle" means a vehicle, trailer or semi-trailer or a motor vehicle as ascribed by The Highway Traffic Act.


2. Parking


- (a) Except otherwise provided herein, the parking of vehicles is permitted on all highways within the municipality.
 - (b) No person shall park a vehicle on any street so as to obstruct the entrance to a driveway or approach leading to private premises.
 - (c) No person shall park a vehicle in any "No Parking" area as designated in appendix A, at any time whether such areas are marked by signs erected and maintained in accordance with the provisions of subsection 3 to indicate that parking is prohibited.
 - (d) No person shall park a vehicle on any highway at one place for a period of time exceeding twenty-four (24) hours.
3. Council shall cause to be erected and maintained at all "No Parking" areas appropriate signs. Such signs shall be visible from the part of the highway to which the restriction applies.
4. No person shall operate a vehicle in the municipality at a speed greater than thirty (30) KM per hour.

Any person who contravenes any provisions of this bylaw is guilty of an offence and liable on summary conviction to the penalty in the General Penalty Bylaw of the municipality.

Bylaw No. 18/88 of the Resort Village of Glen Harbour is hereby repealed.


